EDSE 5364: Behavioral Analysis Consultation and Collaboration

This course is designed as an overview of on the application of applied behavior analysis principals in a consultative and collaborative setting. The course focuses on educational professionals, applied behavior analyst, psychologist, counselors and other human services providers working as consultants and in collaboration to create positive behavior change for students and clients. Prerequisite: EDSE 5325, EDSE 5360, EDSE 5361, EDSE 5362 and EDSE 5363.

Student Outcomes:

- Students will understand the use of competency-based training for persons who are responsible for carrying out behavioral assessment and behavior change procedures.
- Students will understand the use of effective performance monitoring and reinforcement systems.
- Students will understand the design and use systems for monitoring procedural integrity.
- Students will understand establishing support for behavior analysis services from persons directly and indirectly involved with these services.
- Students will understand methods of secure the support of others to maintain the clients' behavioral repertoires in their natural settings.
