## Justification:

The Bachelor of Science in Criminal Justice (BSCJ) is one of the largest undergraduate degrees at TAMIU. In Spring 2011 we had 437 declared CJ majors and in Fall 2011 we had 518 declared majors. Because of our large and increasing enrollment, we need dedicated monies to enhance our undergraduate program. Specifically, monies would be used for two primary reasons: student support services and professional development. To help with career placement, an Internship Coordinator/Outreach Specialist would be hired to oversee our Internship Program and develop our community outreach and service learning objectives. Currently, our internship course (CRIJ 4601) is taught once a year and is limited to 30 students. We would like to expand the Internship Program to service more students by offering the course (CRIJ 4601) in Fall, Spring, and Summer semesters. The Internship Coordinator would also help our majors find open employment positions and provide assistance with their applications and resumes. Funds generated from the Major Fee would also be used to encourage and help students conduct original

research. Conducting research requires us to support CATI by purchasing survey instruments and software (eg SurveyMonkey) and is cost prohibitive for students due to the expense of printing/copying questionnaires. Additional monies are needed to pay membership dues to our undergraduate national honor society, Alpha Phi Sigma, and help defray the cost of travel to national and international conferences. Funds would also be used for on-campus professional development events and activities for our students to afford them a competitive edge upon graduation.
