Each 3-credit course has been selected and or developed based on its context and relevancy for fostering understanding of the learning outcomes associated with law and the American legal system. Students will take 9 of 12 hours from the required classes in Group 1 and 9 hours will be classes at the undergraduate (or graduate if a BAMA/BSMS student) level so long as there is the word "Law", "Legal" "Judicial" or "Courts" in the course title/ subtitle (Group 2).

An undergraduate student who is interested in attending law school upon completion of their degree at TAMIU can pursue any major. Common majors include: Criminal Justice, Business and Political Science; these are not necessary to be accepted into law school. Law school admissions vary from university to university; having any particular major or having a PreLaw minor will not ensure an acceptance into law school.

Criteria for Earning the Minor

MINOR CURRICULUM

The student must:

- Successfully complete 9 hours of the courses found in Group 1.
- Successfully complete 9 hours of elective courses which have "Law" or "Legal" in the title or subtitle; these may be at the graduate level if the student is in the BAMA or BSMS degree program.
- Take no more than 6 hours at the lower division can be used in the minor.
- Not double courses in the major or another minor for the Prelaw minor.
