**NURS 4263 Ethical/Legal Issues in Nursing**. Two semester hours, theory only. This course focuses on legal and ethical issues in professional nursing to include discussions of the ethical and legal underpinnings of nursing practice. Utilizing case studies, students will have the opportunity to analyze actual legal and ethical situations and dilemmas faced by professional nurses and formulate options for resolving them in accord with ethical and legal standards for healthcare. The course will focus also on the intersection and the interrelationship of law and ethics as it relates to the practice of nursing.

## NURS 4263 Ethics and Legal Issues in Nursing

**Course Description**: This course provides an overview of legal and ethical issues for nursing professionals. The student will explore the American Nurses' Association professional code of ethics as well as local, state and federal laws applicable to the professional nurse. The Texas Nurse Practice Act (TNPA) and principles of ethical decision making are applied to nursing practice.

**Course Objectives**: Upon completion of this course the student will have had the opportunity to:

1. Demonstrate knowledge of the Texas Nurse Practice Act and the Texas Board of Nursing Rules that emphasize safety. (6, 8)

2. Demonstrate knowledge of safety requirements and standards of federal, state, and local government, and accreditation organizations. (6, 8)

3. Discuss standards of professional nursing, nursing code of ethics and statutory and case law in relation to professional nursing practice. (6, 7, 8)

4. Participate in the legislative advocacy process. (6, 7, 10)

5. Discuss the role of the Texas Board of Nursing. (6, 8, 9)

6. Describe professional characteristics and values such as altruism, human dignity, truth, justice, freedom, equality, and esthetics. (6, 8)

7. Analyze implications of the mandatory reporting requirements of the Texas Board of Nursing. (6, 8, 9)
