<u>Critical Thinking:</u> Successful practice of inquiry, analysis, evaluation, and synthesis will be measured by the 5-7 page essay (and graded by the attached rubric), which calls for students to examine, analyze, and evaluate the theory from class the student has chosen (defining key terms, explaining the theory and its arguments/evidence used to support, assessing its strengths and weaknesses, building argument and evidence in support of the assessment, taking a position

in relation to the theory, etc.). The critical thinking element will be assessed by the research essay's rubric components designated "Focus," Development," and "Research."

<u>Communication Skills</u>: Effective written communication will be assessed by the research essay's rubric components designated "Focus," Development," "Sentence Structure," and "Grammar/Mechanics."

<u>Personal Responsibility</u>: Connecting choices and actions to consequences and ethical decision-making will be reflected by the student's own moral viewpoint as a debating opponent to the theory discussed or as a second voice in a dialogue with the theory discussed in the research essay. This competency will be assessed using the Philosophical Analysis Rubric used in the research essay, relying on the "Focus," "Development," and "Research" areas.

<u>Social Responsibility</u>: Intercultural competency and engaging the global community objectives will be assessed by the research essay which must inquire as to how both the class theory and the student moral outlook are to be applied in such a way as to synthesize a solution to some major ethical dilemma currently within the profession the student is looking to pursue. The social responsibility component will be assessed by the research essay's rubric components designated "Focus," Development," and "Research."
