Justification of Course Number Change:

This change is being requested to streamline the courses within the Minor in International Leadership. This change will indicate to a student that ideally, this will be the final course they take in the minor.

Change Prerequisite:

Justification of Prerequisite Change:

Currently, there is no prerequisite for this course (LEDR4303). This particular course is now tied to a study abroad experience. Because of this added component and the unique design of the course (the coursework takes place over wintermester and into the following spring), it would be ideal that students meet with the department to discuss their goals and identify if this is an appropriate course for their needs.

Change Information:

Three semester hours

~~This course explores leadership in an international context and builds on material from UNIV 2301. It includes interaction with guest speakers who serve as models of leadership within a variety of areas. Identification of leadership ability through introspection and self-understanding. This course is a capstone which will include assessment of student learning outcomes through a posttest linked to the pretest in LEDR 2301.~~

This course explores leadership in an international context and setting. Students participating in this faculty-led study abroad experience will explore international leadership content while immersing themselves in the culture of the site country.

Upon return to the United States, students will have one semester to complete an independent project with regular consultation from the faculty member. This capstone will include an analysis of their experiences prior, during and after the trip abroad and will build upon their experiences in other courses from the leadership minor.

Students who are unable to travel abroad should consult their advisor and department chair one year in advance to facilitate accommodations to this course.

Prerequisites: Departmental approval is required for this course. (as per change listed above).

Justification of Description Change:

These edits are being requested to reflect the study abroad component to the course and format of capstone project.
