Discussion on UCC 128 - the course will be implemented as an option to UNIV 1102 provided a library component is included. Dr. Ortiz will be instructor of record using a team approach. Compensation for faculty will be made in consultation with Dr. Arenaz. Prefix/number/title for the course were changed from UNIV 1103 Global SLEPT Issues Seminar to INTL 1101 Global Issues Seminar. It will be a 1-hour course with 2 hours of contact. The committee recommended that the course reside in the Department of Social Sciences. Dr. Norris will discuss with the department.

III New Business

Dr. Lira advised the committee that ECO 1399 - YES Camp had been discussed with the Deans and the Core Curriculum Committee to determine its use as a social behavioral science course in the Core. The consensus was that the course had too narrow a focus to meet the exemplary objectives set forth by the Coordinating Board. Students who have taken the course will be advised that the course may not apply to the Core but may be used as an elective if there is room in the student's degree program.
