ACAT assessment (a national exam given by a large percentage of social work programs) covers eight skill areas: diversity, populations at risk, social and economic justice, values and ethics, policy & services, social work Practice, HBSE, and Research methods. As a whole on the National Level 68% of students score between 400 and 600. Six cohorts have now taken the ACAT

#### Indicate when assessment will take place

Fall

#### Criteria/Benchmark

Eighty five percent of students will score within the National Norm between 400 and 600 in each skill area.

Every five years an alumni survey will be conducted to assess both level of preparedness for employment and graduate school and passage of the state licensure exam.

#### Indicate when assessment will take place

Annual

#### Criteria/Benchmark

Evidence gathered from the alumni survey will provide evidence that eight five percent of alumni will indicate that they were well prepared for the work they are performing. Evidence gathered on the scores of students who take the state licensure exam will demonstrate that 80% of students will pass the exam and that all students will score at least 70 in each content area.

**Provide narrative:** The results of the six cohorts to whom the ACAT has been administered were compared. While students on the average have consistently fallen within the norm. The last cohort scored the lowest of all cohorts.

Outcome 2  Met Not Met  Provide narrative: The field supervisor evaluations have proved consistent through time. All measures were positive, although the research and policy areas were not as high. The rationale is that students do not always demonstrate their policy and research skills during their internship and their supervisors then assume that they do not have these.
Outcome 3  Met Not Met  Provide narrative: The alumni survey provides evidence that the BSW students do master the skills of their profession and for the most part enter that field. Alumni self-reports indicate that more alumni are applying to graduate programs and more are now taking their licensure exam. None of the students have been denied admission to graduate schools. However, a point of concern is that since TAMIU does not have a graduate program in social work several alumni have been accepted into the schools of business and education. Two are now persuing a Masters in social work and four are applying for a admission to a Masters in social work.

#### How have these data-based changes improved your program/unit?

Curricular changes have resulted based on evidence provided by the assessment measures. The program itself has improved and skills acquisition has improved. However, it appears that ACAT scores a related to GPA scores. A follow-up study will be done in the near future to assess this.
