NLI Signing Dates

Basketball - April 15, 2015 - August 1, 2015

Soccer – February 4, 2015 – August 1, 2015 All other sports – April 15, 2015 – August 1, 2015

Requirements for NLI – Register with NCAA Clearing house, Put on Institutional IRL, Current Transcript

Interps of Interest

Contact with a Prospective Student-Athlete who repeats sophomore year.

The academic and memberships affairs confirmed that an institution may make off campus, in person contact with a prospective student-athlete beginning June 15 immediately preceding the prospect's junior year in high school even if the prospect will repeat the sophomore year; however, once the prospect begins classes as a sophomore for the following academic year, no further contact may occur until June 15 immediately preceding the next academic year.

Length of Official Visit. The 48 hour visit begins at the time the PSA arrives on the campus, rather than with the initiation of the PSA's transportation by a coach or the time of the PSA's arrival at the airport or elsewhere in the community. The PSA's transportation to and from campus must be without delay for personal reasons. The institution may not pay expenses for entertainment but can pay for actual cost of meals in conjunction with transportation. At the completion of the 48 hour visit, the PSA must depart the institution's campus immediately; otherwise, the institution may not pay any expenses incurred by the PSA upon departure from the campus, including cost of the PSA's transportation home.

- Contact Period March 1 May 18, 2015
- Dead Period April 2 7 (noon), 2015
- Dead Period April 13 (7 a.m.) 15 (7 a.m.), 2015
- Evaluation Period During any high school all-star game that occurs within the state in which the member institution is located
- Evaluation Period April 3-7 (12:01 p.m.), 2015
- Evaluation shall be permitted at any all-star contest held during the final weekend of the NCAA Division 1 Men's Basketball Championship in the host city (Indianapolis, Indiana)
- Quiet Period All other dates

Women's Basketball

- Contact Period March 1 May 18, 2015
- Dead Period April 13 (7 a.m.) 15 (7 a.m.), 2015
- Evaluation Period During any high school all-star game that occurs within the state in which the member institution is located
- Dead Period During Saturday before start of the Division 1 Women's Basketball Championship through Wednesday noon after championship game (April 4-8 (noon), 2015
- Evaluation Period During four nonscholastic women's events occurring between May 18 – June 14 selected at the discretion of the institution and designated in writing in the office of the director of athletics
- Quiet Period All other dates
