Alternatively, students may be waived from any or all of the business foundation courses by presenting evidence of having taken equivalent course work at non-AACSB institutions at either the undergraduate or graduate level.

## Application Requirements

- ❑ Complete Application for Graduate Admission. Application requires a \$25 non-refundable application fee. TAMIU Alumni are exempt. Go to [http://www.tamtu.edu/coba/ap/emba/emba\\_application.pdf](http://www.tamtu.edu/coba/ap/emba/emba_application.pdf)
- ❑ Official transcripts of ALL university-level studies. Transcripts must be mailed directly to the Office of Admissions by the granting institutions(s)
- ❑ Official GMAT or GRE test score, taken within the last five years, sent directly by ETS
- ❑ Two letters of recommendation, one-page statement of purpose, and CV (resume)
- ❑ In addition to the above documents, international students must submit adequate TOEFL scores and required financial documentation.
- ❑ Mail the fellowship insert along with the rest of the application material if applying for the Graduate Business Fellowship.
