RE-ADMISSION TO THE SCHOOL OF NURSING

~~Students not enrolled in Clinical Nursing Courses for two consecutive semesters or formally dismissed will be placed on inactive status. Applicants for re-admission to the School of Nursing must be eligible for re-admission to the University. Decisions will be made by the School of Nursing Admissions Committee. The deadlines for regular admission apply to students seeking re-admission. However, admission will be on a space available basis. Re-admission application materials are available from the Office of the Dean of the College of Nursing and Health Sciences.~~

School of Nursing RN and RN to BSN Re-entry policy: Guidelines for re-entry after failure or withdrawal.

A student who withdraws from any nursing course may be required to withdraw from all other nursing courses due to concurrent registration requirements. A student who withdraws and intends to apply for re-entry into the B.S.N. program must apply and return the next time the course is offered otherwise the student will not be considered for re-entry. Applicants for re-entry must be eligible for re-admission to the University. A student applying for a spring course must apply before October 1st, if applying for a Summer or Fall course must apply by April 1st. A student must take and demonstrate competency on all clinical skills required in each nursing course previously successfully completed. Students will only be allowed two attempts to demonstrate competency. Re-entry is based on the number of seats available, student's GPA, and past history of critical incidents and/or clinical warning. There is no guarantee of re-entry.

Explanation of revision: There was a need to clarify policy and provide a timeline for re-entry into the school of nursing. In addition to ensure that the students have the knowledge and skills needed to perform nursing functions safely they will be asked to provide proof of continued skills competency.
