- Candidates on suspension must sit out for long term. Summer sessions are considered short terms and thus must not be supplanted for a long term.
- The COED application fee is \$30.00<sup>2</sup> (Increased mandates from the state increased our responsibilities for admission oversight) Changed to \$15 per approved TAMUS Fees. 3/22/13
- Option to graduate without completing Student Teaching Semester:

COED candidates in their culminating semester may supplant/substitute 12 credits from a pool of specified courses in lieu of completing their student teaching requirement for certification. By doing so candidates electing this route may graduate in the degree program and will not be recommended for certification. Candidates choosing this route must:

- Be in the culminating semester of their degree program;
- Be in good standing in the College of Education by having a TAMIU 2.7 GPA or higher and a 2.7 or higher GPA in the major;
- Have a "C" or better in all course work (including course work completed in the Core Curriculum); clarification on page 3.
- Complete all program requirements except student teaching plus one course remaining;
- Register for EDCI 4399 Issues in Curriculum and Instruction;
- Register for nine (9) additional credit hours from a select pool of courses approved by the College for this culminating term;

- Forfeit eligibility to obtain approval by the College of Education to sit for any TExES exam as an undergraduate program completer;
- Sign a statement of agreement.

Post-graduation certification may be attained through either a post-baccalaureate or Alternative Certification Program of one's choice.
