Brendan Townsend presented the following courses:

MUSI 1301 Music Fundamentals. Paul Niemeyer moved and Carmen Bruni seconded to approve the assessment plan with the corrections. Motion passed.

MUSI 1306 Music Appreciation. Deborah Scaggs moved and Paul Niemeyer seconded a motion to approve the course with some editorial corrections. Motion passed.

MUSI 1301 American Popular Music. Bernice Sanchez moved and Deborah Scaggs seconded to approve the course after revisions to the CCLOs were made and other edits were incorporated. Motion passed.

Some discussion regarding MUAP 1113 and MUAP a213 followed. The Committee expressed concern that since the course descriptions indicate the students are taking private lessons, assessment of

teamwork might be problematic. Brendan clarified that the students have to work with either an ensemble or an accompanist for part of the performance evaluation. The Committee reached consensus that the course description and syllabi of all MUAP courses be amended to indicate that the student is required to perform with either an accompanist or an ensemble and that the courses be presented at the meeting on March 29, 2013 for consideration.
