



## Tax Exempt Program Process

Thank you for choosing to use the Amazon Business for Education Marketplace.

Provided that you are an authorized buyer for a Tax Exempt Organization, you are now able to set up tax free purchasing for qualified items within the Amazon Business Marketplace. Please know that most, but not all items within the store are eligible, so please take note of the line item tax listing in your shopping cart before completing your purchase. ### Amazon Tax Exemption Program (ATEP) Enrollment

Many organizations qualify to make sales tax exempt purchases based on state law. The Amazon Tax Exemption Program supports sales tax exempt purchases from Amazon.com LLC, Amazon Digital Services, Inc., Warehouse Deals, Inc. or Amazon Services LLC. Please contact your tax advisor to determine if your purchases qualify for sales tax exemption. [Learn about eligibility](#)

The Amazon Tax Exemption Tool will guide you through the process of enrolling in our program. At the start of the process you will be asked to select the states in which you qualify for sales tax exemption and the type of exemption for your organization. From there, you'll be prompted to answer questions or upload documents specific to the sales tax exemption for which you qualify. Please allow 15 minutes for tax exemption certificates created via the Amazon Tax Exemption Tool to be active. Certificates uploaded may take up to 24 hours.
