ATHLETIC COMPLIANCE REMINDERS

NCAA RECRUITING TEST "DIV 2 UNIVERSITY"

- Modules are scheduled to be available on Monday, April 1, 2019.
- Athletic Compliance will not be able to enroll coaches into the courses until April 1st.
- Coaches won't have access to the courses until they are enrolled.
- Modules must be completed by Thursday, August 1, 2019.
- Coaches who do not pass or complete the modules are prohibited from contacting, evaluating PSA's, and participating in countable athletic related activities with the coach's team until required modules are completed.

13.1.2 PERMISSIBLE RECRUITERS.

- 13.1.2.1 Authorized Staff Members. All in-person, off-campus recruiting contacts with a prospective student-athlete or the prospective student-athlete's relatives or legal guardian(s) shall be made only by authorized athletics department staff members. Such off-campus contact by representatives of an institution's athletics interests is prohibited.
 - 13.1.2.1.1 Off-Campus Recruiters. An institutional staff member is not permitted to recruit off campus until he or she has been certified on an annual basis as to knowledge of applicable recruiting rules per Bylaw 11.6.1.1. However, institutional staff members (e.g., faculty members) may contact prospective student-athletes for recruiting purposes on campus or within the locale of the institution's main campus during the prospective student-athlete's official visit.

Amateurism Certification Tasks

• To better align processes and reduce the occurrence of undelivered or ignored requests, Eligibility Center staff will no longer send emails requesting information for a PSA's amateurism certification. Effective immediately, should additional information from the PSA, their club team, previous college or NCAA member institution be needed, a task will be assigned in the PSA's account. All tasks will have detailed instructions on how the party should respond. **Click Here**

Final Amateurism Certification Reminder for Students

- PSAs enrolling full time at an NCAA Division I or II college or university in Fall 2019 may request their final amateurism certification starting April 1.
- To request final amateurism, PSAs should log in to their Certification Account at eligibilitycenter.org and:
 - Review their added sports and answers to Sports Questions.
 - Check their graduation and enrollment dates and update if necessary.
 - Review any open tasks and complete necessary information.

• A PSA has 7 days from the NLI issuance date to sign. It's NOT just one signing day



7-DAY SIGNING DEADLINE

A prospective student-athlete has 7 days from the issuance date to sign the NLI. The issuance date is noted on the NLI signing page. The NLI expires if not signed within the 7-day deadline.

Dead Period: April 4-9 (ends at noon)

Contact Period : April 1-3, 9-15*, 17-30* (see explanation below).

*April 5 through April 9 (12:01 p.m.), 2019: Evaluations shall be permitted at any all-star contest held during the final weekend of the NCAA Division I Men's Basketball Championship in the host city (Minneapolis, Minnesota).

*During any high school all-star game that occurs within the state in which the member institution is located shall be considered an evaluation period.

Women

Dead Period: April 4-10 (ends at noon); and April 15 (begins at 7 a.m.) through 17 (ends at 7 a.m.).

Contact Period : April 1-3, 10-15*, 17-30*
