## 17.02.17 Voluntary Athletically Related Activities

- Student-athlete must not be required to report back to a coach or other athletics department staff member (e.g., strength coach, trainer, manager) any information related to the activity.
- The activity must be initiated and requested solely by the student-athlete.
- Student-athlete attendance and participation in the activity (or lack thereof) may not be recorded for the purpose of reporting such information to coaching staff or other student-athletes.
- Student-athlete may not be subjected to penalty if he/she elects not to participate in the activity. Nor may be provided recognition or incentives (e.g. awards) for his/her attendance or performance in the activity.

## NLI

### NLI Provision 8

- I understand all participating conferences and institutions are obligated to respect my signing and shall cease contact with me and my family members after my signing this NLI which includes me and my family members not initiating contact with athletic staffs at other institutions. Any contact in excess of an exchange of a greeting is not permitted regardless of the conversation. The conversation does not have to result in recruiting discussion for a recruiting ban violation to occur. I shall notify any coach who contacts me that I have signed an NLI. Once I enroll in the institution named in this document, the NLI Recruiting Ban is no longer in effect and I shall be governed by applicable NCAA bylaws.

NLI member institutions must cease communication with a prospective student-athlete and his/her family members after signing an NLI with another NLI member institution.
