Cleared For Practice?

- Completed Forms: SA's must complete their required compliance forms in ARMS, sign in to ARMS with your TAMIU email address and password.
- Attend Compliance Meeting: SA's must attend the beginning of the year Athletics Compliance education meeting. Please see Mr. Miller or Mr. Gonzalez for scheduled times.
- **Receive Medical Clearance**: SA's must pass their physicals and the Athletic Compliance Office must receive medical clearance from the Athletic Training Staff.

Participation Before Certification

• If SA has not been certified by the NCAA or TAMIU, they may practice, but not compete for a maximum of 45 days, provided they are enrolled full-time or have been accepted for enrollment as a regular full-time student. After this 45-day period they must have established full certification to continue to practice or compete, or minimum requirements as a partial qualifier to continue practicing.


