ATHLETIC COMPLIANCE REMINDERS

PTD APPLICATION FOR MIDYEAR ENROLLEE

A student-athlete entering the institution at the beginning of the second semester of an academic year is subjected to:

- Good academic standing
- Completion of 9 hours in previous term of full-time enrollment.
- Completion of 24 hours earned each academic year. (including summer)
- 4- year transfer minimum cumulative GPA of 2.0 earned by the beginning of each fall term. (2.2 GPA for 2-year transfer)
- 2-year transfer complete credit hour requirements:
 - 6 hours English
 - 3 hours Math
 - 3 hours Science

NATIONAL LETTER OF INTENT

By signing a National Letter of Intent, a prospective student-athlete agrees to attend the designated college or university for one academic year. Pursuant to the terms of the National Letter of Intent program, participating institutions agree to provide athletics financial aid to the student-athlete, provided he/she is admitted to the institution and is eligible for financial aid under NCAA rules.

An important provision of the National Letter of Intent program is a recruiting prohibition applied after a prospective student-athlete signs a Letter of Intent. This prohibition requires participating institutions to cease recruitment of a prospective student-athlete once a National Letter of Intent is signed with another institution.

A prospective student-athlete must sign the NLI and athletics aid agreement within 7 days of issuance, or else the NLI is invalid, this deadline would be February 11th if the prospect receives the NLI on February 4th.

MEDIA RELEASE REGARDING SIGNING.

Publicity released by an institution concerning a prospective student-athlete's commitment to attend the institution shall occur only after the prospective student-athlete has signed a National Letter of Intent or after the prospective student-athlete's signed acceptance of the institution's written offer of admission and/or financial aid or after the institution has received his or her financial deposit in response to its offer of admission. Such communications, which are not limited in number or content, may be released to media outlets at the institution's discretion.
