ATHLETIC COMPLIANCE REMINDERS

14-CONSECUTIVE-CALENDAR-DAY PERIOD

- Following the institution's final contest a student athlete is prohibited from engaging in countable athletically related activities.
- **Exception** End-of-Season Meetings, it is permissible to have end-of-season team and individual meetings at any time that is not CARA (e.g. watching game film, physical activities).
- Between the end of the 14-day period or the end of the non-championship segment, and 1-week prior to the beginning of the institutions final exam period a SA's participation in weight training, conditioning and/ or team activities shall be limited to a maximum of 8 hours per week, of which not more than 2 hours per week may be spent on team activities.

FINAL-EXAMINATION PERIOD (DATES)

- Final-examination period (Monday, December 3 Saturday, December 8)
- 1-week prior (Monday, November 26 Sunday, December 2) all CARA
 outside the playing season are prohibited to the beginning of the institutions
 final examination period through the conclusion. Voluntary individual
 workouts monitored by S&C personnel shall not count against the weekly
 hour limitation.
- Reading day (Wednesday, November 21)

NLI DEAD PERIOD (DATES)

NLI Dead Period begins Monday, November 12 at 7 a.m. and ends
 Wednesday, November 14 at 7 a.m.

CONTACT AND EVALUATION PERIODS (13.02.4)

Dead Period (13.02.4.4) - a time when it is not permissible to make inperson recruiting contacts or evaluations on or off the members institution's campus or to permit official or unofficial visits by PSA's to the institutions campus. The provision of complimentary admissions to a PSA during a dead period is prohibited, except as provided in Bylaw 13.7.2.3 for a PSA who visits an institution as part of a group. During such a dead period, a coaching staff member may not serve as a speaker at or attend a meeting or banquet at which PSA's are in attendance, except as provided in Bylaws 13.1.9 and 13.1.9.1, and may not visit the PSAs' educational institutions. It remains permissible, however, for an institutional staff member to write or telephone PSA's during this period.


- FAFSA drives will be offered on the following dates.

OFFICIAL VISITS (THINGS TO REMEMBER)

- ELIGIBILITY High school prospects no earlier than June 15th preceding their junior year in high school; and
- 1. Current official or unofficial transcript
- 2. Register with NCAA Eligibility Center, and
- 3. Placed on institution's IRL
- Transfers (2 or 4 year)
- 1. Current official or unofficial transcript
- If prospect is in first semester or quarter they would be required to present a high school transcript.
- HOST Student host may receive \$30 each day for entertainment for prospects and their relatives.
- **48 HOUR** Maximum time is 48 hours for all official visit, the 48 hours begins when prospects arrives on campus or receives entertainment.
- **COMP ADMISSIONS** Maximum of 5 complimentary tickets via pass list for regular season home athletic events.
- **MEALS** Institution can provide actual cost of meal for prospect and relatives.
- **ENTERTAINMENT** Institution shall limit entertainment, meals and lodging on the prospects official visit to a prospective and their relatives.
- TRANSPORTATION Institution may pay actual round-trip transportation cost for the prospects official visit to campus provided a direct route between prospects home and the institution is used.
- BOOSTERS Confined to campus only.
