WINTER BREAK BYLAWS

- 17.1.6.8.3.1 Voluntary Athletically Related Activities. A student-athlete shall not participate in any voluntary athletically related activities on campus during the winter break (see Bylaw 17.02.18), unless the facility is open to the general student-body.
- 17.1.6.8.3.2 Transportation During the Winter Break. An institution shall not provide transportation in conjunction with away-from-home competition during the winter break.
 - 17.1.6.8.3.2.1 Exception—Travel on the First Day of the Winter Break. An institution may travel on the first day of the winter break after an away-from home competition, provided that it is the earliest practical opportunity to return to campus.
- 17.1.6.4.6 Vacation period and Between terms. Daily and weekly hour limitations do not apply to countable athletically related activities occurring during an institution's official vacation period, as listed in the institution's official calendar, and during the academic year between terms when classes are not in session. If such vacation periods occur during any part of a week in which classes are in session, the institution is subject to the daily and weekly hour limitations during the portion of the week when classes are in session and must provide the student-athletes with a day off (see Bylaw 17.1.6.5), which may be a vacation day.
