## CRRSAA Required Reporting – Quarterly Report

Date of Report 4/9/2021 for the Quarter Ended 3/31/2021

In accordance with the reporting requirements of Section 18004(e) of the Coronavirus Aid, Relief, and Economic Security Act, Texas A&M International University (TAMIU), an institution receiving funds under section 314(a)(1) of the Coronavirus Response and Relief Supplemental Appropriations Act, 2021, is providing the following information:

1. TAMIU acknowledges that the University signed and returned to the Department of Education the Certification and Agreement. The institution further certifies it will use a minimum of 50% of the funds, or \$4,750,878, received under Section 18004(a)(1) of the CARES Act and an equal amount received under Section 314(a)(1) of the CRRSA Act to provide Emergency Financial Aid Grants to students.
2. TAMIU will receive \$9,501,756 from the Department pursuant to the University's Certification and Agreement for Emergency Financial Aid Grants to Students.
3. The total amount of Emergency Financial Aid Grants distributed to students under Section 314(a)(1) of the CRRSA Act from January 1, 2021 - March 31, 2021 was **\$1,925,390**. The full **\$4,750,878** under Section 18004(a)(1) of the CARES Act was fully expended as of October 30, 2020.
4. The estimated total number of students at TAMIU eligible to participate in programs under Section 484 in Title IV of the Higher Education Act of 1965 and thus eligible to receive Emergency Financial Aid Grants to students under Section 314(a)(1) of the CRRSA Act is **6,904 for Spring 2021**.
5. The total number of students who have received an Emergency Financial Aid Grant under Section 18004(a)(1) of the CARES Act is **4,036** and under Section 314(a)(1) of the CRRSA Act is **1,950** as of the dates listed in number 3 above.
6. TAMIU has awarded grants of up to \$1,500 under Section 18004(a)(1) of the CARES Act and up to \$1,000 under Section 314(a)(1) of the CRRSA Act. Currently enrolled students were able to apply for grants via a simple online application process. The TAMIU Emergency Services Committee received the applications, reviewed them for completeness and eligibility under the CARES and CRRSA Act, and coordinated the awarding of the funds. Eligible students were able to apply for grants for expenses related to the disruption of campus operations due to coronavirus, including housing and food insecurity, medical expenses, and lack of educational support and supplies (including technology).

TAMIU Cares will provide just over \$9.8M in emergency grants to students. Of this, 96%, or \$9,501,756, are federal funds while the remaining 4%, or \$394,000, is from non-governmental sources.
