- <u>Self-Analysis Report-SAR</u> (Using your most recent practice EXAM results in Certify Teacher, first click on the DETAILS tab on the last column for the EXAM Mode you most recently attempted. You will now review the percentage of correct answers based on each competency. This page will show you all the tested competencies by Domain. - <u>Correct Answer Report-CAR</u> (Go to the REVIEW QUESTIONS tab located at the bottom center of the page and click REVIEW. This tab will show you the correct and incorrect answers you got on your exam. Click on the incorrect choices one at a time and complete the CAR (see below). Make sure to ONLY review questions for which you answered incorrectly. Review question and correct answer choice. Then scroll down to determine the competency and the skills tested for this question and include the <u>CORRECT ANSWER REVIEW</u> (the reason for the correct answer choice).
