## IV. Speaker / Presentation

#### University Updates – Dr. Pablo Arenaz

- Welcomed TAMIU Staff.
- Reminded that students will be back on Tuesday and faculty will be tested on Tuesday morning when they return to campus. Only faculty will be tested Tuesday morning.
- EOC (Emergency Operations Center) Meeting with the City of Laredo, last week showed COVID numbers were modest. TAMIU will continue to monitor and adjust as needed.
- TAMIU will continue to do surveillance testing; including faculty, students, and staff.
- Protocol for working with COVID has changed, TAMIU will be following the City of Laredo recommendations.
  - If you are COVID positive you will be asked to isolate for 10 days.
  - If you are fully vaccinated (fully vaccinated is defined as having both doses within 6 months or if you are beyond the 6 months with both doses and have had your booster shot.), you may request an alternative work location after 5 days, to work remotely during last days of isolation. This will help those who are asymptomatic by limiting the number of sick days they must use.
  - Employees are not required to work from home after 5 days. If they feel they need the full time to recuperate then it is allowed. Working from home needs to be requested and approved by the supervisor.

# Q&A with the President

- Why does the new rule [alternative work request] apply only to those with the full vaccination status? That is part of the CDC guidelines. For not fully vaccinated individuals, there is a certain set of isolation processes they would have to go through. This is following what the CDC is recommending.
- Will students be required to test? Students are not required to test but are highly encouraged to test. Students have been coming in on their own to test. Some groups will be required to test.
- Will random testing continue this semester? Yes.
- Are there any changes to in-person student event capacities? TAMIU is requiring social distancing, 3 feet distancing for events. We will continue to do what was done in the fall.
- Is isolation required for close contact if you are vaccinated? Quarantine and monitor, continue to do was done in the fall. Contact HR for more details.
