

THE ECONOMIC IMPACT OF TEXAS A&M INTERNATIONAL UNIVERSITY ON LAREDO

Aside from their primary role as centers of education and research, universities can be powerful economic forces in the community. Serving as an economic engine, TAMIU's impact on the local and area economy is greater than the total of the University's direct spending on payroll, goods, services, and construction.

Once salaries, wages and expenses are paid by the University, these monies are spent again by the recipient employees, suppliers and local businesses. We see subsequent rounds of spending when businesses then make their own purchases and hire employees. The indirect stimulation of the economy is also known as the "multiplier effect."


For every 1,000 new students that enroll in TAMIU, the University generates \$36.3 million in new income and supports 522 jobs in the Laredo/Webb County area.

In addition, the 12,000-plus TAMIU alumni that live and work in the Laredo/Webb County area contribute \$306.1 million in income and support 6,766 jobs in the community annually.






